17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Situated on the west side of Cedar Street, this residence is among buildings of the nineteenth and early twentieth century. These structures have various setbacks from the street and are somewhat inconsistent in their north to south spacing.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE:

This residence is designed in the Colonial Revival style of architecture. As noted in <u>A Field Guide to American Houses</u> (McAlester), the building's identifying features include: two and one half stories; a steeply-pitched, side-gabled roof; double-hung sash windows with multi-pane glazing on the first story; and a principle, three-ranked facade with symmetrically balanced windows and center door.

The first two stories of 159 Cedar Street are covered with clapboards. The uppermost half story's gable ends are clad with fishscale shingles, and each gable end exhibits one square window.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE:

The site of 159 was unimproved until a carriage house for 44 East First Street was constructed ca. 1893-98. The carriage house was converted into an automobile garage ca. 1913-21, and ca. 1921-30 became a plumbing shop. When the present apartment house was constructed ca. 1930, the plumbing shop was incorporated into the eastern half as dwelling units in the building that exists today.

This apartment house is an example of multi-family housing which was constructed as an income-generating property for a non-resident owner. Since its construction, it has been frequently occupied by employees of local industry such as the Corning Glass Works and the New York Central Railroad. The maintenance of affordable multi-family housing such as this has consistently allowed for a broad range in types of people to reside in the area, and consequently contributes to the stability of the Southside Neighborhood.
