11.c. INTEGRITY-List major alterations and dates (if known):

In 1893 this building was L-shaped, and one-and-a-half and two stories in height, at different parts. A small outbuilding was present near the northeast corner of the house. This outbuilding was removed by 1898. By 1903, a bay was added to the north side of the house and a porch is found on the south side. A porch is added to the north facade by 1908 and the house is currrently of this same form.

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Situated on the far north end of lot #3 on East Second Street and adjacent to the alley, the main facade of the house is the north side, towards Second Street and not the alley. It is smaller than most of the homes in the area, and one of two residences located on the south sides of lots #1-7 on block 41, by the alley between Second and Third streets. Other houses in the area are of the Italianate, Greek Revival, Queen Anne and Federal styles.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE:

The earliest representation of this structure is on the 1893 <u>City of Corning map</u> by Heermans and the <u>Sanborn Fire Insurance Map</u>. The later additions of two porches and a bay do not alter the Greek Revival style (McAlester, <u>A Field Guide to American houses</u>) of the original structure, which is represented by the gables which are perpendicular to each other.

116 1/2 East Second Street is a one-and-a-half and two story structure with two intersecting gables. The main gable follows a north-south direction and is above the two-story part of the house. The porches on the north and south sides have shed roofs. All roofs are covered in asphalt and the main gable is pierced by a chimney. The majority of the exterior walls are covered in asphalt shingles, but the north wall of the one-and-a-half story area is covered with aluminum siding.

Almost all windows are two over-two sash. Other sizes are present in the bay and on the east facade. No windows are present on the west facade. The south facade of the main area has a fenestration pattern of two bays. Two doors permit entry to the house and are located on the porches on the north and south sides. The shed roofs of the porch to the south is supported by a single, square pier.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE:

The importance of this structure within the Southside neighborhood of Corning relates to the history of industry in the city. 116 1/2 was built as early as 1860, in the midst of the importance of canals and railroads to the well-being of the city, and just prior to the introduction of Corning Flint Glass Works, in 1868.

The earliest availanble information on the owners of 116 1/2 East Second Street is the 1893 City of Corning map by Heermans, which shows lot #3 as being owned by A. Brockaway. The earliest deed which can be found is that for the sale of the entire lot to Candace Bradfield from John H. Marland in 1920. He was the son of Israel Marland, who owned the adjoining lot #4 in the same block since 1859.

Candace Bradfield later split lot #3 of block 41 into two L-shaped parcels, the houses on which were used as rentals. 116 1/2, as well as 114, East Second Street was then sold to Louisa Williams in 1923. She continued to use it as a rental unit. Other owners of this building at 116 1/2 as well as 114 East Second Street include the following; Norman P. and Florence D. Hultzman (?probably 1952 to 1954) Anthony J. and Helena Golden (1954 to 1960) Harold B. and Marian I. Bosket (1960 to present)
