

### 11c. MAJOR ALTERATIONS AND DATES:

1903- Since 1898 a porch was removed from the north side of the house and replaced with a smaller one. There was also a porch added to the south east corner of the house.

1908- It appears that this house was moved sometime between 1903 and 1908. It probably was moved from the corner of Wall Street and East Third Street to the lot immediately to the east. What is now 105 East Third Street. In addition, The house was rotated 90 degrees so that after it was moved the front of the house faced south instead of east.

1921- A larger porch has been added to the front (south) of the structure since 1908.

1992- The large rear porch has been removed and replaced by two smaller ones. The front porch has been replaced and the existing front porch extends past the south west corner of the house.

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

This residence sets on the north side of East Third Street and is in a neighborhood that has many different representative architectural styles and sizes of houses. This house shares a similar set back from the street with its neighbors and also shares narrow side-yards with adjacent residences.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE:

The massing of this large L- shaped structure with its low pitched hipped roof and wide over hanging eaves is representative of the Italianate style of architecture. The tall narrow windows on the front facade of the house are also typical of the Italianate style. This structure is sided with wood shingles and has a small simple shed style porch on the front. An addition has been attached to the inside corner of this L-shape. This addition has a shed style roof and does not match the architecture of the original structure. This house, while it represents the massing of the Italianate style, lacks the detailing that is usually seen with this style. The other three facades of this house are relatively plain, with no projecting structures or architectural details to note.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE:

This residence was originally situated on the corner of East Third and Wall Streets. The street address at this location in 1888 was listed as 2131/2 Wall Street and in 1893 it was listed as 221 Wall Street. During this time period this house was probably owned by Thomas W. Clark. Thomas and his wife Bridget and their son John lived in this house. It appears that around 1909 this house was moved to the lot immediately to the east, to become 105 East Third Street.
