

11c. MAJOR ALTERATIONS AND DATES:

1903- Since 1893 the porch on the north west corner of the house was removed. The porch on the east side of the house added so that it wrapped around the front south east corner of the house and extended along the front of the house, up to the point where the front gable projects out from the main part of the house

1992- Sometime between 1930 and the present a small one story rectangular shaped structure was added to the south east corner of the house. A two story porch was also added to the rear of this structure sometime in this time period.

- 17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:
 Situated on the north side of East Third Street this residence is among houses of differing architectural styles from separate time periods. It shares a similar set back from the road with its neighbors.
- OTHER NOTABLE FEATURES OF BUILDING AND SITE:
 Designed in the Queen Anne Style, this large residence displays a typical mix of architectural characteristics that are commonly seen with this style. As noted in A Field Guide To American Houses (McAlester) "about twenty percent of Queen Anne houses have simple cross-gabled roofs without a central, hipped unit. These are normally of L-shaped plan" (263). This residence displays this cross-gabled roof shape. The Queen Anne Style was popular in New York State between 1885 and 1910.

The front (south) facade has a prominent gable that projects out from the main front facing gable. The first floor of this smaller front facing gable has clipped corners. In this projecting gable there is also a shallow rectangular window over the large main window. As is often common with Queen Annes, this smaller window contains many small panes of decorative glass. In the gable end there are two small double hung windows that appear to have been part of a pelladian window at one time. However, when the house was resided with aluminum the center arched window was covered, but the sill is still evident. A small entrance porch extends out from the larger main gable and serves to protect the two entrance doors. The west facade includes an impressive patterned masonry chimney and also has a slightly projecting gable and with the clipped corners of the front gable repeated here. The east facade also has a slightly projecting gable with clipped corners on the first floor. There is also a small one story rectangular shaped addition that projects out from the main structure on the northern most half of this side. It appears that this structure was perhaps part of a wrap around porch that existed at one time but has since been closed in The south facade (rear) is less complicated.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE:

Victor Haischer acquired this property from Quincy W. Wellington in 1891 for \$1300.00. Mr. Wellington was a local banker and owned and speculated in land in the Corning area. Victor Haischer was the owner of Corning Granite and Marble works of 152-162 East Market Street. As noted in the 1891 publication, An Illustrated Descriptive Review of Corning N.Y., "Mr. Haischer is an extensive manufacturer of marble and granite monuments, headstones and markers and also a dealer in marble and slate, interior decorations, mantels, floors tiling of all kinds, coping, gates, posts, railings, etc."(30). Mr. Haischer resided at this house for about twenty years.
