### 11c. MAJOR ALTERATIONS AND DATES:

1893- a canted bay was added to the southside of the house and the front porch was extended around the corner from the front of the house to extend along the south side. These alterations took place sometime after 1888.

1898- A canted bay has been added to the north side of the house sometime since 1893.

1903- A porch has been added to the rear of the structure since 1898.

1992- A large enclosed porch has been added to the southwest corner of of the house. A second story porch has been added to the rear of the structure. Both these alterations took place sometime after 1930.

# 17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

This residence sets on the east side of Wall Street and shares the same large size as its neighbors. However, this house has a considerably larger lot and a deeper setback from the street than do its neighbors. This house is also much older than neighboring structures.

#### 18. OTHER NOTABLE FEATURES OF BUILDING AND SITE:

This large house is designed in the Italianate Style of architecture. As noted in A Field Guide To American Architecture (McAlester), "the two stories with the low pitched gently sloping hipped roof and the wide overhanging eaves with the decorative brackets are the main identifying features of this style. The tall narrow windows and the three ranked facade are also typical of this style.

This house is sided with narrow wood clapboards. The front (west) facade has a small one story porch over the entrance door that is supported by two square columns. The corbeled chimney, located at the center of the house is evident from the front facade. The 6 panel entrance door with narrow side lights on either side of the door is not a typical entrance for an Italianate style house. This indicates yhat the original entrance to this structure was probably replaced at some point in the past. Also evident from this front facade is a large enclosed one story porch. This porch was probably added some time after 1930. The north facade includes a small one story projecting canted bay. This bay has the same gently sloping roof and wide overhanging eaves as the main house. The south facade includes the same style of projecting canted bay. The rear (east) facade has several attached structures that have been added at different times through the years.

## 20. HISTORICAL AND ARCHITECTURAL IMPORTANCE:

Mr. John Fedder probably owned and lived in this residence in the late Eighteenth and early nineteenth century. <u>As noted in An Illustrated Descriptive Review of Corning N.Y.</u>(J. A. Miller and Co.) "John W. Fedder of the firm of J.B. Collins and Co. is the manager of their

mammoth department store at Corning N.Y. Mr. Fedder has also been prominently identified with Cornings interest in an official capacity, having held the office of President of the village in 1899 and 1890."
