11c. INTEGRITY: Major alterations and dates.

Between 1913 and 1921, two major changes occurred. Sanborn maps indicate in 1921 that the exterior of this frame structure was "Cem. Cov'd" or stuccoed. Also during this period, the northern portion of the front (west) porch across the projecting gabled bay was removed. Sometime after 1948 the porch on the north facade was enclosed and the front (west) porch removed entirely. In 1986 an new asphalt roof was applied over the existing roofing material. Finally, in 1989 the bay window on the south facade was "rebuilt."

17. INTERRELATIONSHIP OF BUILDINGS AND SURROUNDINGS:

Located on the east side of Wall Street, facing west, this residence is one in a group of late nineteenth and early twentieth century homes which are similar in scale. The setback for this residence is similar to that of its neighbors to the north and south. There are large hedges along the perimeter of the west facade.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE:

Though many details are absent, this ca. 1909 Queen Anne-style house exhibits many traits common to the gabled-ell cottage type of this style. The house has a cross-gabled roof with a circular window or vent present at the center in each gable. The exterior walls have all been stuccoed. The front (west) facade of the house contains a facing gable with a canted bay on the first story underneath. The covered area created by the second story overhanging the canted bay to its south serves as a roof for the main entrance which is located here also. On the north facade there is a one-story projecting bay with a hipped roof form. The south facade contains a bay window on the first story under the gable end of the wing projecting to the south.

To the rear (east) is a nearly full width one-story extension with a shed roof clad in metal sheets. Both the north and south facades of this extension have parapets with a coping surface on top rising above the shed roof level. At the rear (east) of this extension is a semi-enclosed shed area under shed roof contiguous with that of the extension.

The foundation for the entire house is of cut limestone.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE:

The property upon which this residence was constructed was subdivided from Lot #1, Block 39, in 1906 by its owner, Lucy Wood. The northerly portion of Lot #1 went to Charles A. and Effie D. Carr. The southerly 45 feet of this subdivision was conveyed to William T. and Bertha L. Moran in June of 1908. It is conceivable that the house, constructed during the years 1908-1909, was a wedding gift from the Moran's to their daughter Bertha B. Moran Hart who, with her husband James L., was conveyed the house and property in April of 1909.

234 Wall Street has had a long succession of owners since Bertha Hart sold it in 1920. The owner of greatest longevity was Nina D. O'Bryan, who owned the house from 1937 until early 1961. Before her,

Corning Glass Works had owned the property from 1920 to 1937. The current owners, Larry and Lorraine Shapiro purchased the property in April of 1990.


