


11c. Between 1903 and 1908, a small rear porch was added. The one-story enclosed porch on the north side of the house also appears to be a 20th century addition.

- 17. This house is located on the east side of Walnut Street in a residential neighborhood. This section of Walnut Street contains primarily Italianate and Queen Anne-style residences, but other styles are represented as well. The size and setback of this house from the street are similar to those of other houses on Walnut Street. The lot size is similar to the others on the same block of Walnut Street.
- 18. This two-and-a-half-story, wood-frame residence exhibits several features of the Queen Anne Style, such as irregular massing, a hipped roof with gables, and Queen Anne sash windows. The other windows on the house are primarily one-over-one-light double-hung sash.

The front facade, which faces west, is notable for the pair of double-hung sash windows in the gable, each of whose sashes is a Queen Anne sash. An exterior chimney, which extends up through the front gable, is visible from above the second story of a two-story projection on the north of the front facade.

20. Like the property at 214 Walnut Street, this property was originally owned by Mary and Jerome B. Maltby, who built this house before 1893, the year in which it appears on city engineer Harry C. Heermans' map of Corning. In 1899, its first known occupant is listed in the city directory. This was Leigh R. Hunt, superintendent of schools, who lived here with his wife Mary and a young servant, Margaret Hassett, in 1900. The Hunts occupied this house until about 1909. During the 1910s it was occupied by William W. Allen, secretary-treasurer of The Gorton Chocolate Company and, in 1913 at least, of The Munger Candy Company as well.

In 1919, John J. O'Brien, Jr., purchased the property from the executors of Jerome Maltby's estate. The house was divided into two units from about 1918 to 1928, occupied mostly by Corning Glass Works employees, including O'Brien. O'Brien worked his way up from a clerk in that organization to credit manager. City directories indicate that he rented out part of the house in later years.

O'Brien died in 1964. At the time of his death, the house was assessed at \$14,250, which was determined to be its true market value. The house was owned from 1964 to 1984 by Lewis M. Dewey, a plumber, and his wife, Kathryn.
