11c. The differences between the two halves of this building suggest that they were built at different times. Sanborn Fire Insurance Company maps show no changes to this house between 1903 and 1930. A one story rear addition, similar to the existing one on the north side, was removed after 1948.

- 17. This house is located on the northeast corner of Walnut and Fourth streets in a residential neighborhood. This section of Walnut Street contains primarily Italianate, Queen Anne, and Colonial Revival-style residences. As a double house, this house is somewhat larger than others nearby, and the lot size is slightly larger as well. The setback is similar to that of other nearby houses.
- 18. This two-story, wood-frame, hipped-roof Italianate-style double house was apparently built in two (or more) stages, since the two halves are quite different. The north half of the front facade, which faces west, is two bays wide, with two-over-two-light double-hung sash on both stories. The south half, which projects out slightly farther than the north half, is three bays wide, with six-over-six-light double-hung sash on the second story and two-over-two-light double-hung sash on the first story. The differences between the two halves extend to the interior as well; the newel posts on the main staircases in each half are

different, for example. The full-width front porch is quite recent, although it replaces an earlier full-width porch.

Rectangular bays project from the north and south facades-two from the north and one from the south. The western of the
two bays on the north facade is two stories high, while the other
two bays are one story.

This residence exhibits features characteristic of the Italianate Style, such as rectangular massing, a flat, hipped roof, and widely overhanging eaves.

20. This Italianate double house was built some time between 1857 and 1882. It was purchased by Mary Maltby in 1873, but it is not known if there was a house on the site yet at that time. Mary and Jerome Maltby, a wholesale grocer, owned this house until Jerome's death in 1914; Mary had died in 1886.

The first known occupants of this house are not listed at this address in the Corning city directories until 1899, when Andrew B. Maltby, Jerome Maltby's son, and Lewis N. Lattin move in to 222 and 224, respectively. Lattin was a cashier for J. B. Maltby Inc., and later a bookkeeper, secretary, and secretary-treasurer for the same company. He was also mayor of Corning in 1914-16, when he was still living in this house. He was evidently a favorite with his employer, Jerome Maltby; Maltby

continually updated his will with codicils, and by the final version in 1914, Lattin's bequest had increased from \$50 in the first draft, to \$1000 and a promise that Maltby's estate would pay the premium on Lattin's life insurance policy.

Andrew Maltby and a domestic lived here for only a couple of years; 222 was subsequently occupied by Robert M. Swallow, an American Express agent, drayman and teamster, who became a trucker in the early 1920s. In the 1927 city directory, Swallow appears at 224 rather than 222, replacing Lattin. By 1929, the Swallows had moved out entirely. The house was subsequently occupied mostly by widows and working people—Corning Glass Works employees, a grocer, a freight agent, and teachers. Both absentee landlords and owner-occupants have owned the house since then.
