### 11c. MAJOR ALTERATIONS AND DATES:

A enclosed rear porch was constructed in 1970. In 1973, a small single-story addition and a brick chimney were added to the north facade. No other major alterations are known.

# 17. INTERRELATIONSHIP OF BUILDINGS AND SURROUNDINGS:

Situated on the east side of Walnut Street, this residence is one of a row of nineteenth- and early twentieth-century homes. The styles, setback, spacing, and sizes of the houses are inconsistent.

## 18. OTHER NOTABLE FEATURES OF BUILDING AND SITE:

The massing of this two-story cottage consists of two L-shaped components. The first comprises the front (west) half of the house, containing two steeply-pitched intersecting gables facing north and west. A single-story wraparound porch covers the front (west) and continues down the north facade to the entrance in the corner of the ell. The second component forms the rear (east) half of the house, featuring two steeply-pitched intersecting gables facing east and south. The east gable is higher than the other three and forms a very small front-facing gable where it intersects the front (west) half of the house.

There is a very small single-story addition located in the northeast corner of the house. There are two brick chimneys, on the south and north facades. A single-story enclosed porch is situated at the rear (east) of the structure.

# 20. HISTORICAL AND ARCHITECTURAL IMPORTANCE:

This house is constructed on the southern half of Lot #1 of Block 70, as laid out in the 1855 Brewer and Canfield map of Corning. The house borders the imaginary east-west line which divides the property into southern and northern halves.

The south half of Lot #1 was owned by John and Rachel McIntosh before they sold it to Catherine Bachle, widow of Joseph Bachle, in 1869. John McIntosh worked for the Corning Marble Works, located near the corner of Cedar and Market streets. In 1874, he lived on Chemung Street near Erie Avenue.

Catherine Bachle built what is now 262 Walnut Street, the neighboring house to the south, ca. 1872. In 1901, she sold the property to John and Helen Hannon. John Hannon had the current house (260 Walnut Street) built ca. 1904 and moved there from 262 Walnut Street. He sold 262 Walnut Street to Herman and Maria Hockie. John Hannon was listed in the 1903 Corning City Directory as a trainman; Herman Hockie was listed as a glass engraver.
